

Arthur Imperatore's Gift to the Community



joins The Legacy Society

with a \$2 million gift.

At 81, Arthur Imperatore, Sr. would like to be remembered as "someone who gave back," and tried to make a better world in whatever way he could. He would also like to help others learn the satisfaction of giving at Palisades Medical Center. "You teach philanthropy by espousing it and carrying it out, in fact," said Mr. Imperatore as he described his pledge of support to Palisades Medical Center. Mr. Imperatore has provided for a \$2 million bequest to the Medical Center.

Mr. Imperatore abounds with energy and keeps a grueling schedule. Well known on the Hudson River waterfront, Mr. Imperatore has made his life's work new beginnings for the community he calls home. His story of success earned him countless awards and honors in the fields of education, healthcare and medical research among others. His interests are quite diverse. Born in West New York to an immigrant family of 10 children, Mr. Imperatore worked his way through school. As a young man he started a trucking business with his brothers, which at one point employed 2,300 people. Mr. Imperatore launched the Port Imperial Ferry

that has grown into today's NY Waterway Ferry Service with over 32,000 daily commuters, and proudly opened the brand new ferry terminal in Weehawken this year. He was the energy behind bringing the New Jersey Devils to their Meadowlands home when he bought the Colorado Rockies in the 1980's to move them east. He has also developed 350 acres of Hudson River waterfront property including Port Imperial bringing thousands of new residents and businesses to the now thriving area. Many have shared special occasions dining in Arthur's Landing with panoramic views of Manhattan.

Thirty years ago Mr. Imperatore was one of the driving forces behind today's Palisades Medical Center. When Mr. Imperatore had a vision to create a waterfront community, he felt the necessary ingredients included quality medical care. "I wanted it nearby," explained Mr. Imperatore. "Somebody said to me 'Why don't you do something about that?' — So I did." In the 1970's Arthur Imperatore's community leadership gathered more than 55,000 signatures on a petition, and through his meetings with many state and local government officials, the application to build was finally approved. On September 10, 1978 the doors were opened.

Palisades Medical Center: News to Know

- The brand new Visitors Parking Lot is open for guests. The \$2 million renovation dramatically improves our parking amenities for visitors and patients, and affords easy access to the Medical Center's main entrance and Emergency entrance. The area also takes advantage of the riverfront view and Manhattan skyline. A beautiful river walk, rich with plantings and seating areas, helps to complete the Hudson River walk stretching from the Palisades Park on the north to the Port Imperial ferry terminal to the south. This entire project was made possible by the efforts of the Honorable Albio Sires.
- The US Department of Health and Human Services has awarded a grant to Palisades in the amount of \$275,000 that will allow us to move forward with our planned renovations of the emergency



department. This \$1 million project will enhance our clinical services and environment of care. Phase I will include an upgrade in technology to connect each patient bay with the central communications system. These upgrades will allow for quicker admissions through bedside registration, and ongoing monitoring of real-time updates of test results. Phase II expands the already existing Fast-Track Service allowing for an accelerated system for care of patients presenting with urgent, but not life-threatening conditions. Special thanks to Congressman Steve Rothman for all his efforts and support of Palisades.

- The New Jersey Department of Health and Senior Services awarded a grant to Palisades for the development of a new Stroke Center. Plans for the new Stroke Center will include a new triage system and state-of-the-art telemedicine capabilities in conjunction with area Emergency Medical Services so communication is clear when minutes count. Statistics show that when intervention can be administered within three hours of onset of a stroke, the impact of the stroke can be diminished.
- The Medical Center has conducted a comprehensive Strategic Planning Process with representatives from clinical and administrative areas as well as community members from the hospital's boards. The blueprint for the future will support the diverse healthcare needs of our community including facility improvements, new program development, financial soundness, and recruitment and retention of quality professionals. New programs currently in development include a Stroke Center, Diabetes Center, Pediatric Rehabilitation Therapy and a Wound Care Center.
- Driving home the significance of community involvement and private contributions, members of the Foundation Board of Governors were instrumental in supporting the healthcare needs of the community through the strategic plan.

- The "Breakfast with the CEO" program was launched providing community members an opportunity to learn about and comment on the Medical Center's future plans. The first two programs were conducted in small round-table discussions and included local businesses and residents.
- A Wound Care Center is being constructed which will feature hyperbaric oxygenation therapy. The wound care team will include endocrinologists, podiatrists, cardiologists, physical therapists, nutritionists and plastic surgeons.
- A recognition reception was held August 10 to thank the donors who made the new Obstetrics Unit possible and to unveil the donor plaques for the *Delivering* the Future Campaign.

How to Get Involved Happenings at the Harborage

As the Harborage celebrates its 15th anniversary, the staff takes time to reflect on accomplishments throughout the years. "I remember when we opened the Harborage," said Edward Davis, Administrator of the Harborage since day one. "We held a double dedication ceremony with the hospital on April 12, 1991. And we received our first patient in May." Mr. Davis recalls, "the neighborhood was so different then, we didn't have any development to the north or south of us." He credits the foresight of the Medical Center's Board for building an extraordinary facility to meet the needs of the community. In 1991, the population over the age of 65 was growing significantly and quality facilities were scarce.

The Harborage opened with 180 beds, but has grown to 245 beds including a special care ventilator unit that is still one of only twelve in the state of New Jersey. The dedicated sub-acute care unit was opened three years ago to provide even greater continuum of care with the hospital. The Harborage continually receives glowing scores from the New Jersey Department of Health and Senior Services in their annual assessments. Mr. Davis acknowledges the dedication of the staff for the continuous growth. Almost thirty members of the staff have been with the team since the beginning.

Over 3,000 families have benefited from the extraordinary care of the Harborage since opening. "Every family has a story," said Mr. Davis. "We've been by their sides providing care, comfort and company - and in many ways have become members of their extended family." To acknowledge that dedication, the Harborage's Anniversary Celebration is a family reunion. The September 29th event invites all families who have been a member of the Harborage family to mark the special occasion with a party and reunion with the staff.
